



SEASON TICKET GUIDEBOOK

**Information & Important Dates for
Full and Half Season Ticket Holders**

2026-2027

I. FULL SEASON TICKETS

A. DEPOSITS & PAYMENTS

A minimum deposit of \$100 per account will be required to reserve your same seats and parking pass from the 2025-2026 season. This deposit is non-refundable. See deposit deadlines at the end of this document.

Your entire account balance must be satisfied by October TBD, 2026. We reserve the right to withhold your season ticket packet until the balance is satisfied. Unpaid seats may be voided from the system without notice after the payment deadline.

You will be given the option to (1) pay your account in full or (2) set up a payment plan. For payment plans, we will require you to put a card on file. Payments will be automatically withdrawn on the 15th of each month unless otherwise requested. The initial deposit may not be included in your payment plan.

During the month of February 2026, there will be a 5% "pay in full" discount off the ticket amount for any cash or check payments. This is not available for card payments.

B. CHANGING SEAT LOCATIONS

Full season ticket holders wishing to change their seat location for the 2026-2027 season may submit requests starting February 2, 2026. Seating requests are accepted on a first come, first served basis. New seat location requests may or may not be able to be fulfilled.

All current season ticket holder seats and parking passes will be held for you until May 22, 2026 with or without a deposit. Starting June 1, 2026 any seats and parking passes that do not have a deposit will be made available to the public. After this deadline, your seats, parking passes and/or Club 611 passes will no longer be guaranteed to you.

C. PARKING PASSES

Parking passes are not included with season tickets, however if you purchase one it will be included in your season ticket packet at time of pick up. Any full season ticket account that purchased a parking pass for the 2025-2026 season will be guaranteed the opportunity to purchase a parking pass for the 2026-2027 season until the deposit deadline of May 22, 2026.

There are two types of parking passes for full season ticket holders:

Parking Pass A is \$115 per pass and is a single season-long pass that must be shown upon entry at each game. Parking Pass A will also be accepted for preseason, postseason and exhibition games. We are only afforded a limited number of these per our agreement with Berglund Center. If you have been a season ticket holder since the beginning, you likely have a Parking Pass A. Our staff will confirm what type of pass you have upon renewal.

Parking Pass B is \$210 per pass (equates to \$7 per game) and consists of 30 individually dated parking passes, one for each of the 30 regular season home games. A pass with the correct date must be shown upon entry at each game. Dated passes are not exchangeable. Parking Pass B does not cover any game outside of the 30 regular season home games. We are only permitted to sell a limited number of these passes.

New accounts or accounts without a parking pass may request to be added to the parking pass waitlist in order of deposit date with Full Season Ticket Holders prioritized. If any passes open up, waitlisted accounts will be contacted beginning July 29, 2026. Payment for pass(es) is due by October TBD, 2026. This amount may be added to monthly payment plans or may be paid in full at the time of notice. Accounts that are on the Parking Pass B waitlist will be upgraded to Parking Pass A if spots open. Accounts that are waitlisted for parking will be upgraded to Parking Pass B before they would be upgraded to Parking Pass A.

D. CLUB 611 PASSES

Accounts that had purchased Club 611 passes for the 2025-2026 season may purchase passes for \$90 each for the 2026-2027 season. New accounts may be added to the Club 611 waitlist in order of deposit date with Full Season Ticket Holders prioritized. This excludes sponsorship accounts.

E. CORPORATE PARTNERS

Corporate partners and sponsors that have full season tickets do not need to participate in the same renewal process as non-corporate accounts. Your existing seats, parking pass, and Club 611 passes will be held until your renewal meeting or announced deadline. F. BENEFITS

Full season ticket holders receive the following benefits:

Giveaways: Full season ticket holders will receive all giveaways. Some of these giveaways may apply to adult tickets or children tickets only. Accounts must have a \$100 deposit by August 7, 2026 to be guaranteed these giveaways. This benefit does not apply to complimentary or traded ticket accounts. Giveaway items and dates are subject to change. Giveaways must be redeemed within the dates listed on the voucher. Vouchers will be provided at the time of pick up before the 2026-2027 season begins.

Free Friend Fridays: Full season ticket accounts will receive free vouchers for designated Friday games. There will be one dated general admission voucher per seat in your account. (For example, if you have three full season tickets, you will receive three Free Friend Friday tickets per selected game.) Free Friend Friday vouchers must be redeemed at the Berglund Center Box Office or through your account manager. Seat upgrades may be completed at the Berglund Center Box Office for the difference in price. You cannot upgrade these vouchers online. These tickets are not able to be exchanged for different game dates. Free Friend Friday tickets are not provided for complimentary, traded or corporate partner accounts.

Exchanging Unused Season Tickets: Full season ticket holders may exchange any unused 2026-2027 season ticket for a future regular season home game of the 2026-2027 season. **All exchanges must be completed through Rail Yard Dawgs staff via email or in-person at least 24 hours prior to the event. Requests in-person or via**

email on the day of the game will not be satisfied beginning at the start of the 2026-2027 season. Each exchange is subject to a Scan Count Report, which displays the number of unused tickets per account.

Merchandise: Full season ticket holders may receive a 10% discount on full price Dawgs merchandise. Discounts are not available online. Must have a valid discount card present at time of purchase. Discount does not apply to raffles, auctions, sale items, customized items or other items as specified. These guidelines also apply to all off ice officials and sponsor accounts.

Playoff Tickets: If the Rail Yard Dawgs make the playoffs and host a home game(s) at Berglund Center, season ticket holders may purchase a Playoff Package to guarantee their season ticket seats by the posted deadline. Seats that are not secured through a Playoff Package are not guaranteed to be available through Berglund Center Box Office or online. Season ticket holders must keep a card on file when signing up for 2026-2027 playoff packages. Cards will be charged each time an additional home game is secured by the team.

Early Entry At Games: Full and half season ticket holders may enter 30 minutes earlier than other patrons by using Gate 7 and Gate 8. (For example, for a 7:05 P.M. puck drop Gates 7 and 8 will open at 5:30 P.M.) All other gates will open at 6:00 P.M. Gate 7 is ADA-friendly. Gate 8 access will be based on availability and may not be guaranteed. Please help us keep these gates exclusive by not allowing non-season ticket holders to utilize these entrances.

Skills Competition Tickets: Complimentary tickets to the Rail Yard Dawgs skills competition will be included with your package. You will receive the same number of skills competition tickets as you have seats. (For example, if you have three full season tickets, you will receive three skills competition tickets.)

G. TICKET OPTIONS

We will offer season ticket holders four options when receiving their tickets. Each account must specify their preference at time of renewal. All requests are final by

August 7, 2026. The ticket booklet option will be the default selection if no preference was specified. Accounts that deposit after the deadline of August 7, 2026 will have the option to receive standard printed tickets on standard ticket stock or digital tickets through account manager.

Ticket Booklets consist of a single booklet per seat that contains 30 single-use tickets (one ticket per game.) Ticket booklets also include your giveaway vouchers and Free Friend Friday tickets. After the deadline of August 7, 2026, ticket booklets will not be available. Lost or stolen ticket booklets will be replaced with printed or digital tickets for free.

Digital Tickets are uploaded to the account holders account manager address per account. Digital tickets may be shown on a mobile device upon arrival to the game. Those who select the Digital Ticket option will still receive Free Friend Friday tickets digitally through Account Manager. Giveaway vouchers, and other passes will still be printed tickets/passes. There is no deadline or cost associated with digital tickets. Digital tickets may be requested at any point in the season.

Lanyards consist of a single pass attached to a lanyard designed to be worn around your neck. Accounts that select this option will receive one lanyard per seat. Lanyards will display the seat location and a singular barcode that may be scanned once per game. Those who select the lanyard option will receive Free Friend Friday vouchers through Account Manager. Those can be requested to be printed and picked up in person. Giveaway vouchers and other passes will be printed tickets/passes. Lost or stolen lanyards may be replaced for \$20 or printed/digital tickets may be provided for free.

H. RETURN & OTHER POLICIES

Full season tickets are fully refundable, except for the \$100 non-refundable deposit, until the season ticket packets have been picked up by the account holder or authorized person. There are no refunds on corporate sponsor tickets. Additionally, full season tickets are subject to all posted policies found online at <https://www.railyarddawgs.com/policies>. Season ticket holders are encouraged to review our policies prior to purchasing season tickets. All policies are subject to change without notice.

II. HALF SEASON TICKETS

A. DEPOSITS & PAYMENTS

A minimum deposit of \$100 per account will be required to reserve your same seats and parking pass from the 2025-2026 season. This deposit is non-refundable. See deposit deadlines at the end of this document.

Your entire account balance must be satisfied by October TBD, 2026. We reserve the right to withhold your season ticket packet until the balance is satisfied. Unpaid seats may be voided from the system without notice after the payment deadline.

You will be given the option to (1) pay your account in full or (2) set up a payment plan. For payment plans, we will require you to put a card on file. Payments will be automatically withdrawn on the 15th of each month unless otherwise requested. The initial deposit may not be included in your payment plan.

B. CHANGING SEAT LOCATIONS

Full season ticket holders wishing to change their seat location for the 2026-2027 season may submit requests starting March 2, 2026. Seating requests are accepted on a first come, first served basis. New seat location requests may or may not be able to be fulfilled.

All current season ticket holder seats and parking passes will be held for you until May 22, 2026 with or without a deposit. Starting June 1, 2026 any seats and parking passes that do not have a deposit will be made available to the public.

I. PARKING PASSES

Parking passes are not included with season tickets, however if you purchase one it will be included in your season ticket packet at time of pick up on October TBD, 2026. Any half season ticket account that purchased a parking pass for the 2025-2026 season will be guaranteed the opportunity to purchase a parking pass for \$105 for the 2026-2027 season (15 games only) until the deposit deadline of May 22, 2026. Parking passes for half season ticket holders are referred to as "Parking Pass C" and are only accepted for your 15 regular season games.

New accounts or accounts without a parking pass may request to be added to the parking pass waitlist in order of deposit date with Full Season Ticket Holders prioritized. If any passes open up, waitlisted accounts will be contacted beginning July 29, 2026. Payment for pass(es) is due by October TBD, 2026. This amount may be added to monthly payment plans or may be paid in full at the time of notice.

J. CLUB 611 PASSES

Accounts that had purchased Club 611 passes for the 2025-2026 season may purchase passes for the 2026-2027 season. New accounts may be added to the Club 611 waitlist in order of deposit date with Full Season Ticket Holders prioritized.

K. BENEFITS

Half season ticket holders receive the following benefits. Items noted with * are subject to deadlines.

Giveaways: Half season ticket holders will receive giveaways for the games that have giveaways listed IF they select that game as one of their 15 games. Some giveaways may apply to adult tickets or children tickets only. Accounts must have a \$100 deposit by August 7, 2026 to be guaranteed these giveaways. Giveaway items and dates are subject to change. Giveaways must be redeemed within the dates listed on the voucher. Vouchers will be provided at time of pick up.

Exchanging Unused Season Tickets: Half season ticket holders may exchange any unused 2026-2027 season ticket for a future regular season home game of the 2026-2027 season. All exchanges must be completed through Rail Yard Dawgs staff via email at least 24 hours prior to the event. Requests on the day of the game will not be satisfied. Each exchange is subject to an Scan Count Report, which displays the number of unused tickets per account.

Playoff Tickets: If the Rail Yard Dawgs make the playoffs and host a home game(s) at Berglund Center, season ticket holders may purchase a Playoff Package to guarantee their season ticket seats by the posted package

deadline. Seats that are not secured through a Playoff Package are not guaranteed to be available through Berglund Center Box Office or online.

Early Entry At Games: Full and half season ticket holders may enter 30 minutes earlier than other patrons by using Gate 7 and Gate 8. For example, for a 7:05 P.M. puck drop Gates 7 and 8 will open at 5:30 P.M. All other gates will open at 6:00 P.M. Gate 7 is ADA-friendly. Gate 8 access will be based on availability and is not guaranteed. Please help us keep these gates exclusive by not allowing non-season ticket holders to utilize these entrances.

Skills Competition Tickets: Complimentary tickets to the Rail Yard Dawgs skills competition will be included with your package. You will receive the same number of skills competition tickets as you have seats. (For example, if you have three half season tickets, you will receive three skills competition tickets). This benefit is also extended to those who purchase half season vouchers.

L. SELECTING YOUR 15 GAMES

Half season ticket holders will receive a form to select their 15 games once the team has released their promotional schedule (TBD, Summer 2026.) Staff will then prepare your tickets for selected games and giveaway vouchers accordingly. This form will be due to our offices by September TBD, 2026. Packets will be ready for pick up on October TBD, 2026.

M. RETURN POLICIES

Half season tickets are fully refundable, except for the \$100 non-refundable deposit, until the season ticket packets have been picked up by the account holder or authorized person. Additionally, half season tickets are subject to all posted policies found online at <https://www.railyarddawgs.com/policies>. Season ticket holders are encouraged to review our policies prior to purchasing season tickets. All policies are subject to change without notice.
